## My Adventures in Acquiring a 2007 XK Coupe by Marty Cohen

About 6 months ago I had an urge to own an XK Coupe, a serious, incurable desire only understood by Jaguar enthusiasts. I settled on a coupe because we have not had the top down on our XJS convertible in over 15 years and I also found the coupe's lines particularly pleasing to my eyes.

I asked Brent McGibbon about his experience in acquiring his XKR, sight unseen, from a Jaguar dealer in Florida and having it shipped to Colorado. His advice was very useful, including the need to engage a professional inspection service. Bill Beeson was also helpful to me in outlining the procedure to register a car purchased out of state in Colorado.

I monitored 3 web sites in search for a car. It was an educational experience. My search criteria were any year, max price \$22,000, less than 60,000 miles, original owner high priority, as I expected that they probably would have cherished the car and would have had the wherewithal to see that the car was properly maintained.

Several weeks ago, 2 cars, original owners, identical years, almost identical mileage, same color, were advertised. One from the Scottsdale Ferrari-Maserati dealer and another from a Scottsdale private party. To make a long story short I arranged to buy the car from the private party, which was his wife's. The car had less than 55,600 miles and new tires with 3000 miles on them. She passed on an F type and purchased a Porsche. I engaged the Lemon Squad to inspect

the car and selected their Exotic Car Option which they recommend for Ferraris, Aston Martins, etc. The inspection is very detailed, including among many other checks, checking paint depth for indication of body repair with an electronic instrument, computer check, and test drive and about 40 photos. They rated the car overall as very good.



I flew down to Phoenix on Thursday, paid for the car and headed home passing through Phoenix, Flagstaff, Albuquerque to Castle Rock.

The car handled beautifully, and the simple, intuitive cruise control was a godsend. One problem arose at a whistle stop at *Chambers Mobil* in Chambers, AZ. I stopped for gas, leaving the 2 smart keys and my cell phone in the car. After filling up, I discovered that I was locked out. Two hours later I was on the road again after AAA was able to unlock the car. I stayed the night in West Gallup, NM and arrived home at 3 PM on Friday.

One smart thing I did was to bring an ice scraper, as when I started out from Gallup in the early morning dark, the windshield and rear window were covered in frost. On the way back, I stopped in Santa Fe for gas where a fellow came over to look at the car and gave me a thumbs up. Arizona only uses a rear license plate so I welcome any suggestions on how to attach the front plate.

## Minutes of the Board Meeting of Oct. 2<sup>nd</sup> at the Oakleys

After a delicious dinner at the home of Frank and Jean Oakley, President Steve Kennedy called the meeting to order at 7:22 pm. Members present were Bob Grossman, Dwight Eisnach, Deanie Kennedy, Gordon Kenney, Gary George, Vince Lane, Brent McGibbon, Frank Oakley, Deborah Ramirez and Jackie Redrupp; Bill Beeson was absent.

### Officer Reports:

Membership Chair Deanie K. reported the club has 109 members which is fewer than a year ago. There were no new members gained at the recent Conclave.

As Treasurer she reported that a deposit has been made to *Caesars* in Las Vegas for \$2,500 toward the *Harrah's* facility where the 2019 AGM meeting will be hosted by our club. The contract has been signed and Kennedys will visit the facility on Oct. 30th. Club members helping run this meeting will need to be on site 4 nights starting Thursday, March 19, 2019. If interested in being part of this event contact the Kennedys.

The Concours event broke even financially and we have extra trophies available for next year.

Steve K. reported that several club members attended the opening of the new "*Flatirons Jaguar*" dealership with several club members' cars displayed. Their management seems interested in working with our club and the new facility is a possible site for our Concours in 2019.

Gary G. reported the show at *Metro Airport* lost money but the CCCC organizers felt it was a success. They have several ideas in mind to make it better next year although there will be no air show.

He also reported the Conclave had about 420 cars with 40-45 being Jaguars. The committee has adequate financial reserves but is working on the issue of "leadership" for the coming years.

Brent M. reported that the "Bids for Kids" event at the *Vehicle Vault* in Parker was a success. The final report shows that \$40,000 was raised for the Children Hospital sports program. Program director Lee Sammens said the amount is higher than last year and he gives credit to the Jaguar club for their contribution. It also showed one can have a successful party even without alcohol service. They will probably use the *Vehicle Vault* again next year as our club recommended.

### Upcoming:

The club Christmas Party will be at *Heritage Bend* again this year and held on Saturday, Dec 1<sup>st</sup>; the club has made the advance deposit. The *Fairfield Inn* at Southland will be the local hotel for over-nighters. Deanie will post details and reservation forms on the club website.

The Kennedys will be attending the *International Jag Festival* starting later this month and will report on it at the November meeting.

At the next monthly meeting on Oct. 9<sup>th</sup> at *Piccolos* Henry Fegley will show slides and talk about his recent trip to the *Goodwood* event in the UK. Nominations will also be taken for the upcoming club elections.

Steve asked board members for suggestions for future programs.

Useful shortcut to web viewing


Many of us routinely view web pages. Most of them require repeated paging down or up from page to page.



**The October meeting of the CCCC included major clarification and definitions regarding the Collector Vehicles category and how they relate to the emission testing program.**

The first category of Collector Vehicles are 1975 and older vehicles. These vehicles are not required to obtain an emissions test and are not required to sign the DR 2839 Collector's Item Affidavit to renew.

The second category of collector vehicles is Collector Vehicles 1976 or later that were registered prior to September 1, 2009. These vehicles are not required to obtain a passing emissions test or sign the DR 2839 Collector's Item Affidavit to renew. These vehicles will remain in this second category until a change of ownership occurs. The new owner may register the vehicle as a Collector Vehicle, but at that time will be placed into the final category below.

The final category of collector vehicles is Collector Vehicles that are model year of at least 32- years old. This means that in 2013, vehicles that are model year 1981 or older qualify as collectors; in 2014, the model year will be 1982; in 2015 the model year will be 1983, etc. This category is broken down into two sub-categories. If the vehicle is being registered in the emissions program area, the applicant will be required to sign the DR 2839 Collector's Item Affidavit and pass emissions to register and renew. If a Collector Vehicle that are model year of at least 32-years old is being registered and not in the emissions program area, these vehicles are not required to obtain an emissions test and are not required to sign the DR 2839 Collector's Item Affidavit.

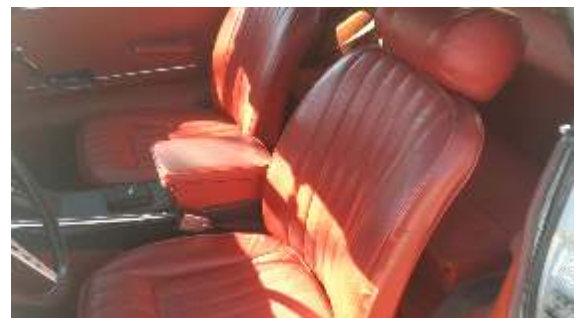
