After the Awards Banquet was the Monte Carlo Night Benefit for the Coventry Foundation, which by the way could always use everyone's support.



Gateway Classic Cars is a consignment organization for the sale of collector, race, and classic cars and trucks. Nationwide they have 17 locations in cities that include places like St. Louis, Atlanta, Chicago, Scottsdale, and Las Vegas. Their total vehicle inventory numbers around 3000 cars. The Centennial facility, which is near American Furniture Warehouse on E-470, has close to 150 beautiful cars and trucks ready to go. The staff of Gateway is very meticulous about the vehicles that they accept as consignments, demanding high standards for originals and restorations. The quality of the cars and trucks offered was obvious as soon as we entered the facility. The variety was huge, ranging from the 1920's to modern models.

Minutes of Meeting, 7 November 2018


The meeting was held at the Forney Museum of Transportation

Meeting with Colorado Department of Revenue officials: John Mack summarized the meeting he, Dick Thompson and Leo Boyle had with Kyle Boyd and Adam Wilms of the DoR to clarify guidelines issued to county clerk and recorders regarding registration of vehicles with **collector series license plates**. The Department is using a new computer system known as CSTARS which may have misled county offices. As reported in an attachment to the October CCCC meeting minutes, there are three categories of vehicles eligible for collector series registration:

- Vehicles built 1975 and earlier;
- Vehicles built 1976 and later that were registered as collector items before September 2009;
- Vehicles at least 32 years of age.

In addition, CSTARS will soon include dual-registration for vehicles with **Year-Of-Manufacture plates**. In any event, it is imperative that owners with YOM plates carry the regular plates as well as certification of the YOM registration with the state.

Electric Vehicles are now at Jaguar Dealerships – Will they work for you?

Today's Topic: "Range", "Range Anxiety", and "Charging"

The often-mentioned advantages of EV's are easy to enjoy and the Jaguar I-Pace will let you experience quick and powerful acceleration, smooth power flow, a quiet drive-train, very few maintenance needs, and "one-pedal" driving by using regeneration for braking. The freedom of not having to visit gasoline stations and fuel costs from 3 to 5 cents per mile are also nice.

But there is the issue of range, i.e., how far can I go before the car needs to be recharged.

Fuel capacity is not measured in "gallons" of gas in the tank but in terms of "kWhr's" (thousands of watt-hours) in the battery. Typically an EV will travel 2 to 4 miles per kWh used and reviews of the i-Pace shows it goes about 2 ½ miles per kWhr used. The 90 kWhr battery pack multiplied by 2.5 miles per kWh predicts a range of 225 miles.

But you don't want to drive down to zero battery left (you wouldn't drive your gas car to empty) so plan on recharging after using 80% of capacity. So the practical range becomes about 180 miles before recharging. How long will it take to recharge? That gets complicated with recharging at Level 1 (120 volts) taking 13 hrs, at level 2 (240 volts) 6 hrs or at a high power DC (direct current) charger maybe 1 ½ hrs, Next month I will discuss recharging places and rates.
