AGM Epilogue

To bring everyone up to date on the Non-AGM, it was cancelled when the COVID 19 outbreak became evident. At first, they did not want to cancel our event, but after several phone calls and emails, from Deanie, the JCNA President, Les Hamilton and the JCNA lawyer, Rob Thus, they finally agreed to cancel our event and refunded our deposit. While the stock market has reacted much more strongly to the COVID-19 outbreak than the H1N1 outbreak in 2009, long-term the Dow Jones recovered from the H1N1 outbreak and is showing signs of recovery from the COVID-19 outbreak.
