CCCC Minutes

CCCC Bylaw Change: The committee met and agreed on the following changes to be made to the By Laws: In Article I. Last sentence of the paragraph, Delete "equal shares among its Member Clubs at that time" and replace with "proportional shares equal to members at the time of most recent renew".

In Article III. 1. Delete "The club must have at least ten (10) members" and replace with "The club must initially have at least ten (10) members". Also in Article III. Last paragraph. Second sentence. Remove "and at each January regular business meeting thereafter".

Article IV. First Paragraph last sentence. Remove "January".

These changes were presented by Carroll Reichen. Motion was made by Carroll Reichen (and seconded by Bret Johnson) to publish them in the minutes of the September 3 meeting. They will then need to be voted on at the **Feb 5, 2025** meeting. This will take an affirmative vote of the authorized Representative of at least two-thirds of the Member Clubs of the total current membership roll of the Council. Current membership is 53 clubs so it will need 36 affirmative votes to pass. In order to secure the best possible representation of the member clubs in a vote to amend the Bylaws, the Council will accept absentee ballots, for this purpose only, cast in writing by the authorized Representative of Member Clubs and received by the Secretary of the Council subsequent to publication of any such proposed amendment, but no less than two (2) days prior to the regular business meeting at which such vote to amend is to be conducted (Feb 5, 2025).

It is also required that the two previous motions be withdrawn and no one can remember who made those motions. Maybe the Secretary can research this and this can be done at the Oct 2 meeting.

Review of August 3rd Airport Show:

Current net income from this show is \$7,125.33 (with \$1,000 still due). This was a very successful event with over 350 classic cars and about 700 spectators.

Two big issues for the show are:

1) We need a show manager (either an individual or a club to manage the event). The event also needs managers to manage the Volunteers, Vendors, Sponsors, Displays, Parking and Set up on Friday and Tear down on Saturday.

2) The Airport can not supply and drive the Hay Rack wagons next year due to their insurance. We need to come up with another way to get the spectators from the Parking Lot to the show and back.

Bill and Betsy went to Vail and came back sick so no presentation tonight.

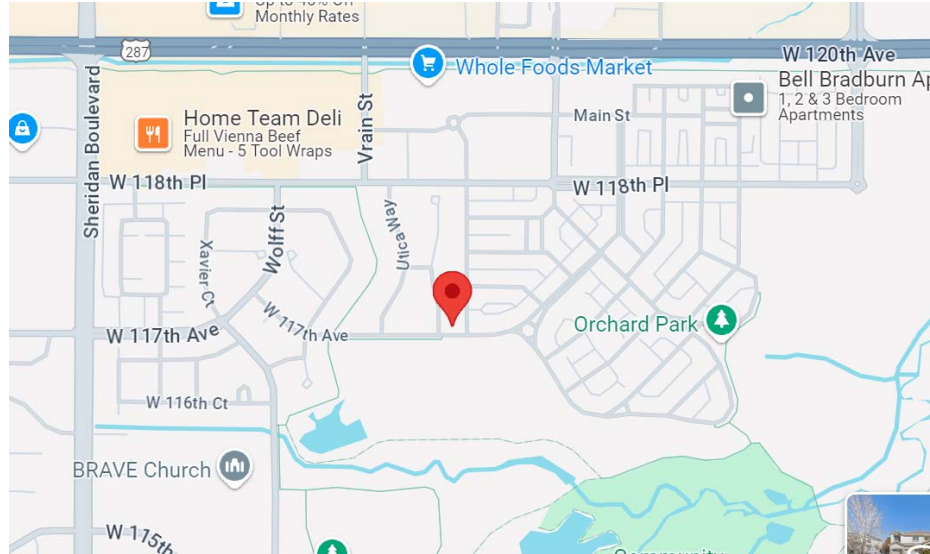

The Green Machine

I have had the E-type, the “Green Machine” (apologies to Dartmouth alumni), since October of 2020, purchasing it from the estate of the original owners, John and Annie Shaver in Billings, Montana, and am the second owner. Not having met them, I don’t know how the car made its way to Montana. The Shaver’s were partners in a Chevrolet dealership in Montana, so clearly had an interest in cars. The Jaguar Daimler Heritage Trust certificate has the Green Machine produced April 17, 1969, in Willow Green with black interior trim – all of which remain original. It was imported through British Leyland in New York, and dispatched to the US on May 29, 1969. Interestingly, the Shaver’s liked E-types as they had both a S1 and S2.

I found the E searching on line in the spring of 2020, trying to decide on how to replace my recently sold Austin Healy BN1. I had been attracted to E-types ever since I first saw one as a college student in the ‘70s in Madison, WI. When I saw this E-type listing, it fit what I was looking for; a running, numbers matching, driver in original condition. So, off to Billings, Montana at the start of the COVID pandemic in July of 2020 to check it out. I pulled into the lot where the car was being stored and saw the E displayed - the bonnet up, the door and boot hatch open, and fell in love with it.

Jerry, the seller, and I went over the car pretty thoroughly and confirmed it was completely original, with 48,000 original miles. It must have been stored since 1976 since the Conoco service station sticker said the next oil change was due in November of ’76, and the date stamp on the tires was ’76. I drove the car and, though rough, thought it was in great shape for a 51 year old car, all original, and the driving connection I wanted. I took plenty of pictures, came back to Denver, and left out the number of times I had to pump the brakes to stop while promising my wife it was safer and more reliable than the BN1 (really?). I got Ted Hummel to help me sort out what repairs would likely need to be done, and get an opinion on price. I called Jerry back, and negotiations began. We came to terms on the price, but came to a stop when I found out there may be a title problem! The title was not in Jerry’s name. A clear title should have been one of my first questions – rookie mistake. It was an open title; it had been signed over to Jerry the prior year (2019) but he had not signed as the buyer. Ownership had not been formally transferred to Jerry, and the car would be sold without Jerry in the line of ownership. Could Jerry sell the car without signing the

title? Since it was the middle of the COVID pandemic, getting Montana DMV to change the title and re-issued it would take months which the Jerry didn’t want to do. I was nervous about buying the car with an open title and didn’t know if the Colorado DMV would accept it.

After calls to a lawyer to sort out how to do this, Jerry and I agreed to a 50% refundable deposit, he would send me the title and I would take it to CO DMV to be absolutely certain they would accept it. Good news - CO DMV had no problem with the title. The deal was on! I overnighted the balance, and waited for his call telling me he had received the check. But, instead the next day I got a call from FedEx. The driver was at Jerry’s house, and a neighbor had come over to let him know that Jerry had unexpectedly passed away that night!

I felt terrible about Jerry’s death as I had gotten to know him over the weeks we were dealing over the car, and his passion for classic autos. But, who owned the car now, and who do I deal with? Turned out Jerry had a partner in the business. I called up his partner and we picked up the deal where Jerry and I had left it. As a bonus he asked if I wanted any other cars Jerry had in addition to the E-type – an XK-140, or a Porsche 356, or a TR3, among others. I passed, perhaps I shouldn’t have, and focused on the E-type. We quickly wrapped things up and had the car delivered to Jaguar Denver to get started.

Since I have had the car, to get it drivable and reliable, I have replaced the clutch, clutch master and slave cylinder, put in new engine mounts, new fuel and water pumps, new brake master and front rotors, a stainless steel exhaust system, replaced all the weather stripping and got new shoes (period correct Vredestein 185x15), replaced all the incandescent bulbs with LEDs, reupholstered the sun visors and headliner, and had the clock restored (thanks Mike Eck!). Has taken about 3 years to get things sorted. Now it runs well, really dependable, and a joy to drive. Every time I take it out, I get a thumbs up from other drivers. People always come up to it in a parking lot. The Green Machine, and all E-types, really leave a mark on people, including me. Every time I take it out I am 21 all over again – and with no phone, no navigation, no problems, it is just a driving experience.
